Checking Plus Service Fee	\$10.00 per month if balance goes below \$250.00

Excessive Withdrawal/Transfer Fee	\$2.00 per item after 6 withdrawals/transfers

Dormant Account Fee	\$5.00 per month after no activity for 12 months, does not apply to members under 21 or over 64 years of age. Account will be closed when account goes below par value of \$5.00
